What is a tax credit?

This is a tax credit, not a tax deduction. A tax credit is a dollar-for-dollar reduction in the actual tax owed. For example, if you owe \$900 in state income taxes and you donate \$400 to a public school for extracurricular activities, you may subtract the \$400 from your tax bill and pay the state just \$500. This is money that you would already be paying in taxes anyway.

Who is eligible?

This tax credit is available to all Arizona individual taxpayers regardless of whether or not they have children in school. An individual can contribute and receive a tax credit for any amount up to \$200, or a couple filing jointly can contribute up to \$400.

Does ALL of my money go to the Hirsch Academy programs?

Yes, 100% of your donation goes directly to the schools for activities that directly benefit students by enriching campus life and learning. None of the money is used for overhead.

Can I designate where I want my money to go?

Yes, you can decide where you want your donation to go. You can designate it for any specific extracurricular activity or program you choose. For more information about the clubs & afterschool activities contact our school at 480-488-9362 and we would love to discuss them with you.
